## **P84 PETITION FOR TRAFFIC LIGHT:**

PS 84 has also started a petition to get a traffic light at the Corner of Grand and Berry in Williamsburg. They are working with Emily Gallagher, Antonio Reynoso's office (and his replacement), Lincoln Restler, and the DOT to get a traffic light at the corner of Grand and Berry. It has always been an issue but it has gotten extremely dangerous. A parent was recently struck by a vehicle and seriously injured. The ps84 community is extremely concerned as if this had been a child the child would certainly have gone under the car. To make matters worse there

is a crossing guard shortage and as of now, there is no crossing guard for the corner of Grand and Berry, the guard must be at Grand and S1st due to school entrance regulations.

The three main things you can do to support the PS84 community is

- 1) sign the petition PS84 <u>TRAFFIC LIGHT PETITION</u>
- 2) call 311 as much as you can and reference Case# DOT-524050-J7S1 and ask for a traffic light at that intersection
- 3) Call 311 and ask for the PS84 Crossing Guard at the corner of Grand and Berry to be reinstated

#### **CLASS SIZE MATTERS:**

The City Council Education Committee held a hearing on adding an amendment to the administrative code that would change the square footage per child to 35 square feet, which means smaller class sizes. Council Member Marissa Manzanares testified along with many other parents, educators, activists and UFT Representatives.

The committee is in support of the amendment despite pushback from the DOE. The committee with take the amendment to a vote later this month.

# PRESENTATIONS

#### **BRILLIANT NYC:**

In order to provide a community perspective of the Brilliant NYC blueprint the D14 CEC has invited Matt Gonzlez from NYU Metro Center, Tiffani Torres an Alumni Student Organizer with Teens Take Charge, and Asamia Diaby from the Alliance for Quality Education.

Matt Gonzalez discussed his thoughts on the current Blueprint for Brilliant NYC. He discussed the history of the current G and T program and encouraged the community to ask itself questions such as "When we create a resource for a small group of students, and make definitions (such as "gifted" meaning being good at taking a test) what does that create in the community as a whole?" Mr. Gonzalez reiterated that many people working and advocating towards and education system that sees every child as gifted and while it feels too late, at least it is moving in the right direction.


Asamia Diaby discussed thoughts about what Brilliant NYC is and what does it mean for education citywide. The main concerns discussed where that it feels as if this program has been set up to fail. These thoughts are based on the timeline it was released, the upcoming change in Mayoral control of education, and concerns about timing, funding and staffing.

Tazin Azad from PRESS NYC added to the conversation stating that there are and have been people thinking about culturally responsible education for a long time. She commented on her experience at the BRILLIANT NYC Community Meeting expressing that many parents, activists, and community people feel that language access is an after thought. The facilitators were not given instruction or taught how to make space for parents who might need communication other than English. So communities are continuously coming up against lack of information. Tarzin encourages legitimate and proven methods to engage folks to be used by the DOE and has expressed that many people in the community have those methods to be utilized, the DOE simply needs to make the effort.

#### **SUPERINTENDENT'S REPORT:**

1) Attendance - Citywide average is 92% and D14 is 91% as a district

2) Brilliant NYC Community Engagement Sessions are happening in every district to identify areas of need and next steps in the design of the program. There is an expert panel on Monday November 29 at 7:30pm. The panel will be moderated by middle school students from our very own District 14

3) The District 14 Equity team will be collaborating with WXY to create a multi-disciplinary team. They will be holding meetings with a variety of constituents from the community.

The Three Equity Goals:

Attendance - improve chronic absenteeism by building inclusive environments by providing supports for families

Culturally Relevant/Culturally Sustaining Curriculum - provide education to students in which they see themselves and engage in learning experiences they connect with AND learning about other cultures.

Professional Learning - address biases and practices that marginalize students by providing principals with knowledge and necessary skills to provide compassionate education. This will be specifically for students identified as living in temporary housing, male Black/Hispanic students, and students with disabilities
